It reveals that company **K&ALE CAMPANY Limited** was removed from the Register of companies as a result of non-filing the financial statement for the year 2022 to 2024.

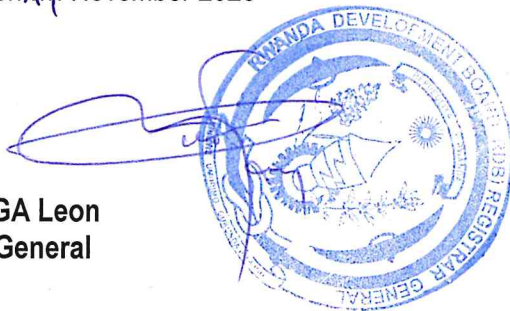
Kindly be informed that **K&ALE CAMPANY Limited** will be re-registered after fulfilling all these requirements:
